<b>Changeover clean</b>	Contaminated accommodation / spread of COVID 19	<ul style="list-style-type: none"> <li>● All changeover cleaning commenced once the guests have left the property</li> <li>● Cleaner self-certifies fit for work and records this in cleaning log</li> <li>● PPE supplied to cleaner</li> <li>● All cleaning / maintenance procedures are adhered to and documented accordingly</li> </ul>				LOW
